- Minimum 10, maximum 15 learners. If fewer than 10 paid registrations, the enterprise is responsible for the cost of the remaining seats.
- One complimentary registration for every three paid.
- Fee per learner:
  - Nonprofit & Independent: \$2,500.
  - For Profit: \$2,850.
